Emissions reduction targets

To continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

GHG emissions was greatly reduced by 31% (scope 1) and 72% (scope 2) in 2023, from our baseline. This was due to enhancements made to our heating, cooling and lighting along with home working continued after the pandemic.

MPD FM Ltd is committed to the Focus on the carbon footprint of our solutions and enhance our climate report disclosure.

Reducing the carbon footprint, consumption of resources and waste production by improving the energy efficiency of our operations.

Developing a low-carbon fleet.

We aim to:

- 1. Raise employee awareness about reducing energy use: Posters in our building and refresher training on our reduction targets.
- 2. Asked our energy supplier to increase frequency of our invoices, allowing us to track our usage and make changes to stay on track of our consumption.
- 3. Decreasing the number of light sources by organizing the workplace according to natural light.
- 4. Only using central heating and no longer using individual heating
- 5. Request an energy audit to target weaknesses of our building to reduce energy waste.

MPD FM Ltd will have a review on the building's insulation and make changes if needed to make the building energy efficient.

Practice sustainable procurement

- When tendering, we ensure suppliers provide their green credentials
- Where practical, we choose local suppliers to reduce travel

Office Working Environment

- Following COVID19, MPD FM Ltd have adopted a hybrid working policy, which allows employees to work from home two days per week, which reduces our carbon footprint as a company
- We will continue to monitor consumption and reconcile with bills monthly to identify anomalies quickly and take corrective action

- MPD FM Ltd undertook a review to ensure our social value activities, metrics & reporting adhere to best practice. A group of stakeholders from our business completed a social value survey and attended workshops to determine and embed our social value commitments.

• For the remaining emissions, MPD FM Ltd will continue to work within our ISO 14001 framework to continue further refining and measurement of our carbon emissions footprint paying more reference to scope 3 and then consider our offsetting initiatives.
