Privacy Policy

1. Introduction

We are committed to safeguarding the privacy of [our website visitors, service users, individual customers and customer personnel].

This policy applies where we are acting as a data controller with respect to the personal data of such persons; in other words, where we determine the purposes and means of the processing of that personal data.

Our website incorporates privacy controls which affect how we will process your personaldata.

We use cookies on our website. Insofar as those cookies are not strictly necessary for the provision of [our website and services], we will ask you to consent to our use of cookies whenyou first visit our website. In this policy, "we", "us" and "our" refer to MPDFM.

2. The personal data that we collect

In this Section we have set out the general categories of personal data that we process [and, in the case of personal data that we did not obtain directly from you, information about the source and specific categories of that data]. We may process data enabling us to get in touch with you ("contact data"). The contact datamay include [your name, email address, telephone number, postal address and/or social media account identifiers. If you log into our website using a social media account, we may obtain elements of the contact data from the relevant social media account provider.

3. Purposes of processing and legal bases

4. Providing your personal data to others

5. Retaining and deleting personal data

Personal data that we process for any purpose or purposes shall not be kept for longer than is necessary for that purpose or those purposes.

6. Your rights

Your principal rights under data protection law are:

- (a) the right to access- you can ask for copies of your personal data;
- **(b)** the right to rectification- you can ask us to rectify inaccurate personal data and to complete incomplete personal data;
- (c) the right to erasure- you can ask us to erase your personal data;
- (d) the right to restrict processing- you can ask us to restrict the processing of your personaldata;
- (e) the right to object to processing- you can object to the processing of your personal data;
- (f) the right to data portability- you can ask that we transfer your personal data to anotherorganisation or to you;

- (g) The right to complain to a supervisory authority- you can complain about our processing of your personal data.
- (h) The right to withdraw consent- to the extent that the legal basis of our processing of yourpersonal data is consent, you can withdraw that consent.

We use cookies for the following purposes:

- (a) Authentication and status- we use cookies [to identify you when you visit our website and as you navigate our website, and to help us determine if you are logged into our website.
- **(b)**Security- we use cookies [as an element of the security measures used to protect user accounts, including preventing fraudulent use of login credentials, and to protect our websiteand services. If you block cookies, you will not be able to use all the features on our website.
